He stated that Cabell County Sheriff Chuck Zerkle and the Cabell County Commission donated a 2016 Ford Explorer to the Milton Police Department. Their generous donation is greatly appreciated. Mayor Canterbury advised that Council would vote on West Virginia American Water Company's offer to purchase Milton Utilities. Before the vote, he allowed audience guests to speak on this issue. If you lost \$91k on water & Sewer You have 9.3 million in debt. I would think that would be a hefty rate increase to cover existing debt, maintain the system as is, as well as provide an upgrade. You mentioned a note increase at the public meeting. It isn't on the handout. Itow much do you anticipate? I am assuming that is for water & sewer? Will there be programs for senions & those on fixed incomes like other utilities offer to assist with their bill?
